Non -Resident Membership

Initiation Fee: \$16,500
\$5000 down payment &
5% financing available over 5 yrs
(Consolidating to one category and will be based on county instead of mileage. Ask for details on qualifying counties.)

Non - Resident A

TEMPORARY LEGACY MEMBERSHIP

This membership is exclusively for Legacy dependents. The membership allows an active member's child (in good standing) to join the club for one year upon turning age 24 at a reduced monthly dues rate, no additional fees and no initiation fee with full club privileges. The account is a sub-account of the parents.

By applying now, you will have the opportunity to lock in current initiation pricing, which will apply once the Temporary Legacy year concludes if you decide to keep the membership.

Monthly Dues Only \$328 (for one year)

In the event the member is relocated outside of Macon or the 35 surroundings counties and elects not to become a non-resident member, the balance of the initiation fee will be waived. In the event the member resigns from the club without being relocated, he/she will be obligated to pay 25% of the balance of the initiation fee at the time of resignation.

Membership Application Process

Obtaining an Application

The sponsoring member may pick up a membership application at the Clubhouse Front Desk or request one by email.

Letters of Recommendation

Each application must include four (4) letters of recommendation: one from the Sponsor and three additional letters from Endorsers.

Photographs

Please include:

- 1-A photograph of the applicant
- 2-A separate photo of the applicant with their spouse and children (if applicable)

Submitting the Application

Return the completed application, including all letters and photos, to the Clubhouse Front Desk or directly to the Membership Director, Tracy Martin. A non-refundable deposit of \$2,500 (personal or certified check only) must be submitted with the application. This deposit will be applied toward the initiation fee and processed immediately.

Review Process

Once submitted, the application will be reviewed by the Membership Committee and the Board of Directors.

Waitlist and Final Steps

If approved, the applicant will be placed on the waitlist (if applicable). Once a spot becomes available, the Sponsor will be contacted to confirm the applicant's readiness.


